Know All Men By These Presents:

That I, Thos. Erskine, as County Auditor in and for the County of Itasca, and State of Minnesota, have been such Auditor at all times herein mentioned; that the following described Tract or Lot of Land, to-wit: The East Half of the Southeast Quarter (E 1/2 of SE 1/4) of Section 28, Township 61 North, Range 26 West of the Fourth Principal Meridian, is divided into parcels of irregular shape, which cannot be described except by metes and bounds, that on the fourth day of February, 1934, I, as said Auditor duly requested owners of said tracts of land, to-wit: Maggie Larson, John J.
