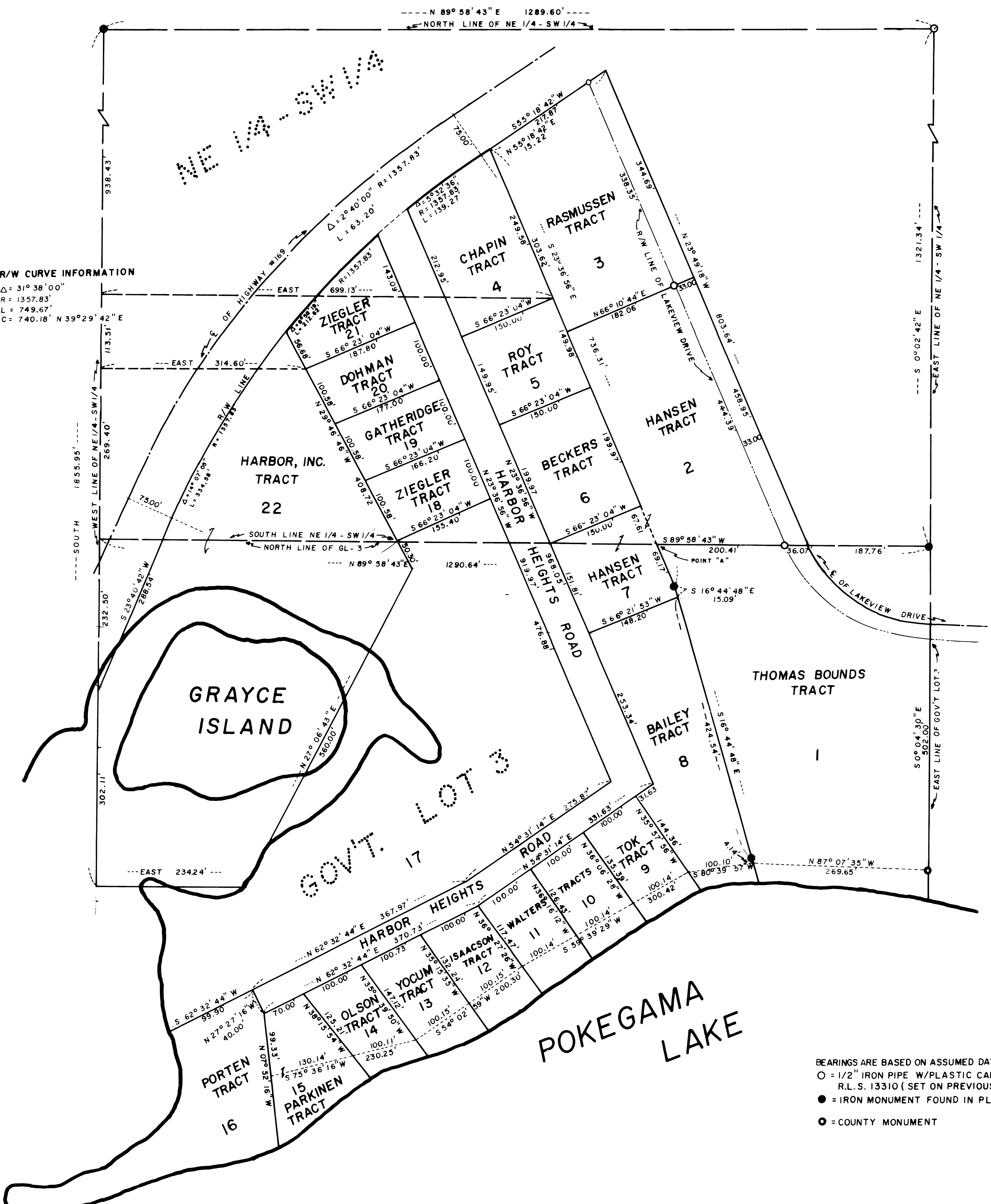

All that part of Northeast Quarter of the Southwest Quarter and Government Lot 3 of Section 8, Township 54 North, Range 25 West of the 4th Principal Meridian lying southerly and easterly of the Southeasterly Right-of-Way of United States Highway Number 169 as it now exists on and across said Southwest Quarter and Government Lot 3 and also lying southerly and westerly of the centerline of Lakeview Drive as it now exists on and across said Southwest Quarter and Government Lot 3;

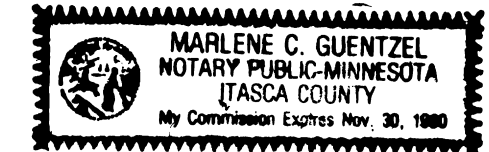

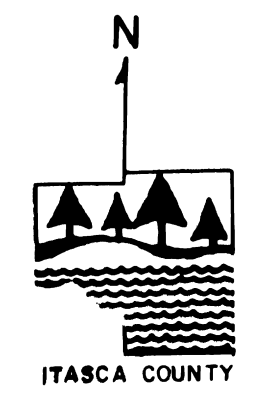

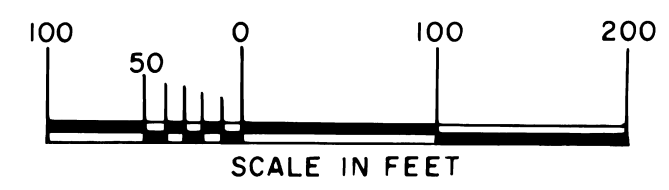
