

That I, R. J. Whaling, as County Auditor in and for the County of Itasca, and State of Minnesota, have been such Auditor at all times herein mentioned; that the North eight (800) Acres of Lot 4, Section 27, Township 55 North, Range 25 West, of the Fourth Principal Meridian, in Itasca County, Minnesota, more particularly described as follows, to wit:

Beginning at the Corner of Sections 21, 22, 27 and 28, Township 55 North, Range 25 West of the Fourth Principal Meridian; Thence East, on the Section line, a distance of 1322.6 feet, to the West 1/16 Corner of Sections 22 and 27; Thence South, on the West 1/16 line of Section 27, a distance of 264.0 feet; Thence West, at an angle of 89°24′30″, from South to West, a distance of 1324.6 feet; Thence North on the line between Sections 27 and 28 at an angle of 88°59′30″, from West to North, a distance of 264.0 feet, to the point of beginning.
